WYABLE accounts allow individuals to save and /or invest money without losing eligibility for certain public benefits programs such as Medicaid, SSI, or SSDI. Earnings in a participant's account are not subject to federal income tax, so long as they are spent on "Qualified Disability Expenses." These accounts are not checking or savings accounts, they are investment. Participants who use WY-ABLE will be investing their money into the different options provided by Vanguard Mutual Funds. While funds can still be withdrawn and spent as needed, WYABLE accounts also allow participants to grow their money and to save long-term for disability expenses.

In the Afton program we had a very beautiful gentle giant visit us and took quite a liking to the clients.

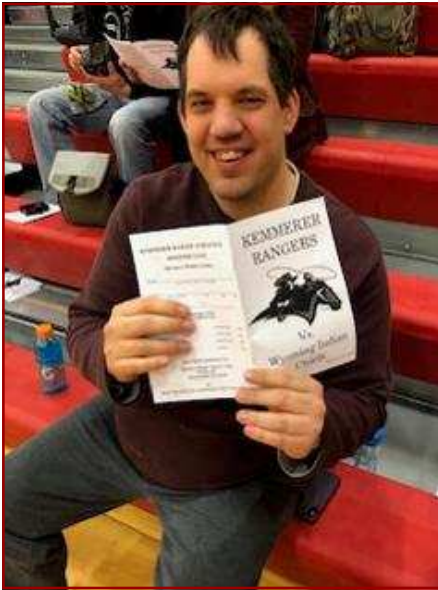

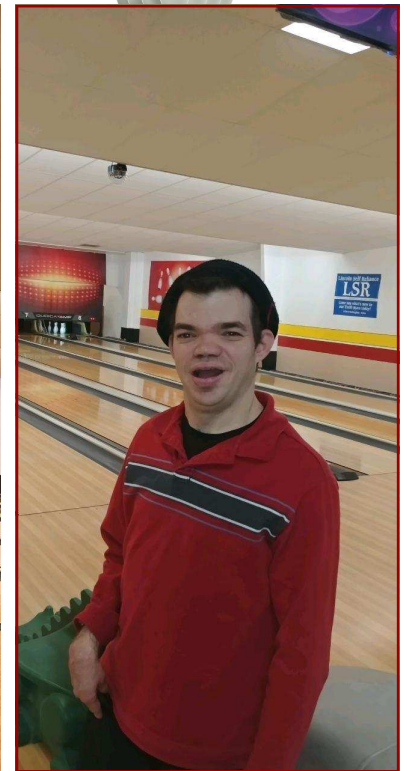
Mission Statement

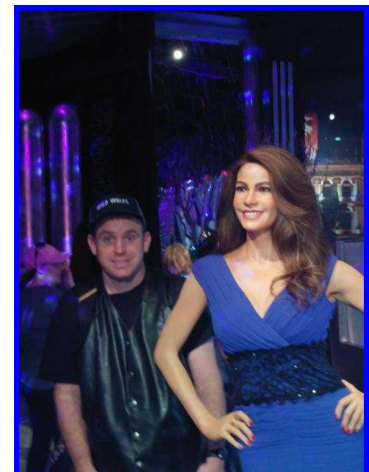
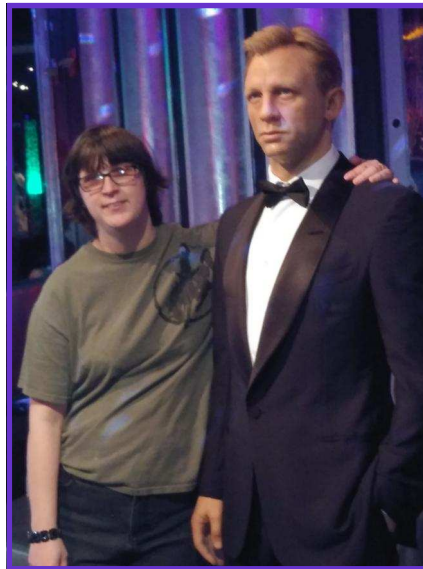
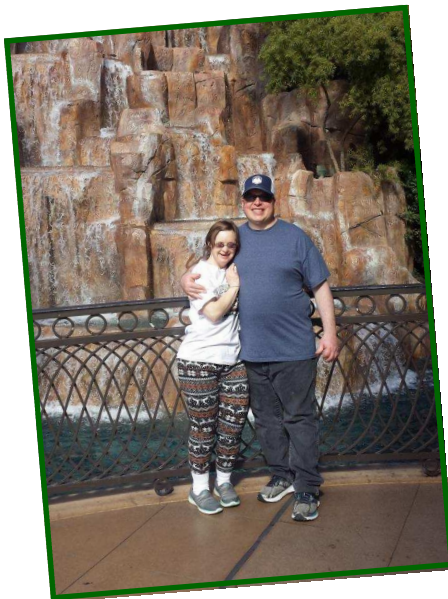
