Lincoln Self Reliance, Inc. ANNUAL REPORT July 1, 2021-June 30, 2022

History

Lincoln Self Reliance, Inc. has been in operation as a Section 501 (c) (3) corporation since July 2000. LSR, Inc. maintains physical facilities in Diamondville, Kemmerer, Afton, Thayne, and Evanston Wyoming. The Administration Office is located in Afton Wyoming.

This past year at our Evanston service locations we continued to have several facility improvements. A major home remodel was completed at our Morse Lee home. All the bathroom had remodeling completed with a full ADA wheel in shower completed on the main floor. A stair lift was installed between the main floor and upstairs bedrooms. The kitchen was completely redone with new flooring, cabinets and countertops. New appliances were also installed (stove, above range microwave, fridge, dishwasher, and stackable washer and dryer. Vinyl plank flooring was installed throughout the home.

In June 2022, LSR purchased a three-bedroom, two-bathroom townhome in the Evanston community. The home was being used for 24-hour Community Living services but owned by a third-party. The third-party owners placed the townhome up for sale and the guardian of one of the clients residing in the home asked LSR to purchase the home so the clients wouldn't be at risk of displacement if bought by someone else.

All LSR program staff and clients are continuing to do well with enduring the COVID-19 Pandemic. There have been multiple staff and clients that have contracted the virus but fortunately there have been no adverse outcomes as a result. LSR

LSR's thrift store located at the 1038 South Washington continued to have another productive year. Donations from the local community continued to increase this past year and customer visits have continued to increase during the year. LSR employed four staff year round to meet the needs of the customers. Gross revenue from the thrift store for the fiscal year was \$111,452.

During the fiscal year ending June 30, 2022, LSR provided services to 60 individuals.

- Thirty (30) individuals received Community Living services through LSR.
- Forty-nine (49) individuals received Adult Day Services/Community Support Services through LSR.
- LSR also provided personal care, supported employment, respite, companion services, and transportation services during the fiscal year.

CARF Accreditation

LSR, Inc. maintains CARF accreditation for Community Integration; Community Housing; Supported Living; and, Community Employment Services: Employment Supports. LSR received a Three Year Accreditation at the conclusion of our accreditation survey conducted in November 2019. "CARF accreditation is a process that demonstrates a provider has met standards for the quality of its services. CARF established these standards to guide providers in offering their services. CARF also uses the standards to evaluate how well a provider is serving people and how it can improve."
