#### HISTORY


Lincoln Self Reliance. Inc. has been in operation as a Section 501 (c) (3) corporation since July 2000. LSR, Inc. maintains physical facilities Diamondville, Kemmerer, Afton, Thayne. Evanston Wyoming. Administration Office is located in Afton Wyoming.


In April 2014 LSR acquired an additional day hab facility with offices and three residential homes in Evanston, WY. LSR purchased the physical facilities from Bridges Habilitation Services. **Bridges** sold their direct care programming to allow them to provide case management services under the new Wyoming Medicaid Waivers. The total purchase price for the physical facilities and clientele was \$1,700,000.00. LSR obtained a loan through Bank of Star Valley for \$1,300,000 and paid for the remaining \$400,000 from reserve accounts. Bridges Habilitation staff were retained during the transaction.

LSR's thrift store located at 1038 South Washington is continuing to grow. local communities have been very supportive of the new thrift store and donations for the store have been very generous. Revenue from the thrift store for the fiscal year was \$41,443.

LSR discontinued case management services at the end of the fiscal year to be in compliance with the new Wyoming Medicaid regulations implemented in April 2014. Under the new waiver case management services have to be a stand alone service. LSR could not continue to employ that case managers overseeing service coordination clients in LSR programming services.

#### PROGRAMS AND SERVICES

On June 30, 2014, LSR was providing services to 80 individuals.

- Forty-seven individuals received Case Management services through LSR.
- Twenty-nine individuals received Residential Habilitation services through LSR.
- Fifty individuals received Adult Day Services through LSR.
- LSR also provided Supported Living, Personal Care, Supported Employment, Adaptive Equipment, Support Brokerage and Intervention Services during the fiscal year.


## **HUMAN RESOURCE**

On June 30, 2014, LSR employed onehundred (100) staff. LSR also employed fourteen (14) persons served on-site.

#### LSR OUTCOMES:

- In a Satisfaction Survey conducted in December 2013, respondents indicated 97% overall satisfaction with Day Hab Services; 100% satisfaction with Residential Services; 100% satisfaction with Case Management Services; and, 100% satisfaction with Skilled Nursing Services.
- LSR did not have any formal grievances filed by client or stakeholders during the fiscal year.
- Of all individuals served in Adult Services 59% participated in paid or volunteer work.
- In an employee Satisfaction Survey conducted in December 2013, respondents indicated 90% employment satisfaction working for LSR.




